**Amendments to the Claims:**

This listing of claims will replace all prior versions, and listings, of claims in the application:

**Listing of Claims:**

Claim 1 (Original): A display control apparatus for image forming apparatus that features:

a first operation panel with which operators can select multiple functions of an image forming apparatus that has aforementioned multiple functions;

a second operation panel that is configured so that it can be loaded and unloaded freely to/from the aforementioned image forming apparatus and with which operators can select aforementioned multiple functions;

a detection means to detect whether the second operation panel is loaded or not when the aforementioned image forming apparatus is turned on; and

a controlling means that controls items that are displayed on the first operation panel according to the result of detection by the aforementioned detection means.

Claim 2 (Original): A display control apparatus for image forming apparatus that features:

a first operation panel with which operators can select multiple functions of an image forming apparatus that has aforementioned multiple functions;

a second operation panel that is configured so that it can be loaded and unloaded freely to/from the aforementioned image forming apparatus and with which operators can select aforementioned multiple functions;

a detection means to detect whether the second operation panel is loaded or not when the aforementioned image forming apparatus is turned on; and

a controlling means that controls the display items so that predefined display items are displayed on the aforementioned first operation panel when the aforementioned detection means determines that the aforementioned second operation panel is not loaded, and adding to the predefined display items, at least a mode button that can switch the display items on the second operation panel is displayed when the aforementioned detection means determines that the aforementioned second operation panel is loaded.

Claim 3 (Original): A method of providing user interface displays in an image forming apparatus, the image forming apparatus having a first, standard display device and a second, optional display device, the method comprising

testing if the second, optional display device is available

if the second, optional display device is available, then providing a first standard user interface to the first display device and an operation guidance interface to the second display device

if the second, optional display is not available, then providing a second standard interface to the first display device

wherein the first standard interface includes an option for the user to select a different interface and the second standard interface lacks an option for the user to select a different interface.

Claim 4 (Original): The method of providing user interface displays in an image forming apparatus of claim 3, wherein if a user selects the option for the different interface, then providing the different interface to the first display device and the second display device

Claim 5 (Original): The method of providing user interface displays in an image forming apparatus of claim 4, wherein the different interface comprises an advanced interface.

Claim 6 (Original): The method of providing user interface displays in an image forming apparatus of claim 5, wherein the advanced interface includes an option for the user to select a custom interface.

Claim 7 (Original): The method of providing user interface displays in an image forming apparatus of claim 6 further comprising, if the user selects the option for the custom interface, then providing the custom interface to the first display device and the second display device.

Claim 8 (Original): The method of providing user interface displays in an image forming apparatus of claim 3, wherein the first standard interface and the second standard interface are substantially identical except for the option for the user to select a different interface.

Claim 9 (canceled):

Claim 10 (Original): A method of providing user interface displays in an image forming apparatus, the image forming apparatus have a first display device and a second display device, the method comprising

providing a standard user interface to the first display device, the standard user interface including an option for the user to select an advanced interface

providing an operation guidance interface to the second display device

if a user selects the option for the advanced interface, then providing the advanced interface to the first display device and the second display device

Claim 11 (Currently amended): The method of providing user interface displays in an image forming apparatus of claim 9 10, wherein the advanced interface includes an option for the user to select a custom interface and the standard interface lacks an option for the user to select a custom interface.

Claim 12 (Original): The method of providing user interface displays in an image forming apparatus of claim 11 further comprising, if the user selects the option for the custom interface, then providing the custom interface to the first display device and the second display device.

Claim 13 (Original): An image forming apparatus comprising

a first, standard display device

a controller

a control program having instructions for causing the controller to

test if a second, optional display device is available

if the second, optional display device is available, then provide a first standard user interface to the first display device and an operation guidance interface to the second display device

if the second, optional display is not available, then providing a second standard interface to the first display device

wherein the first standard interface includes an option for the user to select a different interface and the second standard interface lacks an option for the user to select a different interface.

Claim 14 (Original): The image forming apparatus of claim 13, the control program further having instructions for causing the controller to detect if a user has selected the option for the different interface, and if so then to provide the different interface to the first display device and the second display device

Claim 15 (Original): The image forming apparatus of claim 14, wherein the different interface comprises an advanced interface.

Claim 16 (Original): The image forming apparatus of claim 15, wherein the advanced interface includes an option for the user to select a custom interface.

Claim 17 (Original): The image forming apparatus of claim 16, the control program further having instructions for causing the controller to detect if the user selects the option for the custom interface, and if so then to provide the custom interface to the first display device and the second display device.

Claim 18 (Original): The image forming apparatus of claim 13, wherein the first standard interface and the second standard interface are substantially identical except for the option for the user to select a different interface.

Claim 19 (Original): An image forming apparatus comprising

a first display device

a second display device

a controller

a control program having instructions for causing the controller to

provide a standard user interface to the first display device, the standard user interface including an option for the user to select an advanced interface

provide an operation guidance interface to the second display device

determine if a user has selected the option for the advanced interface, and if so, then to provide the advanced interface to the first display device and the second display device.

Claim 20 (Original): The image forming apparatus of claim 19, wherein the advanced interface includes an option for the user to select a custom interface and the standard interface lacks an option for the user to select a custom interface.

Claim 21 (Original): The image forming apparatus of claim 20 further comprising, if the user selects the option for the custom interface, then providing the custom interface to the first display device and the second display device.

Claim 22 (Original): An image forming apparatus comprising

- a first, standard display device
- means for testing if a second, optional display device is available
- means for providing a first standard user interface to the first display device and an operation guidance interface to the second display device if the second, optional display device is available
- means for providing a second standard interface to the first display device if the second, optional display is not available
- wherein the first standard interface includes an option for the user to select a different interface and the second standard interface lacks an option for the user to select a different interface.

Claim 23 (Original): The image forming apparatus of claim 22, further comprising means for providing the different interface to the first display device and the second display device if a user selects the option for the different interface

Claim 24 (Original): The image forming apparatus of claim 23, wherein the different interface comprises an advanced interface.

Claim 25 (Original): The image forming apparatus of claim 24, wherein the advanced interface includes an option for the user to select a custom interface.



Claim 26 (Original): The image forming apparatus of claim 25 further comprising means for then providing the custom interface to the first display device and the second display device if the user selects the option for the custom interface.

Claim 27 (Original): The image forming apparatus of claim 22, wherein the first standard interface and the second standard interface are substantially identical except for the option for the user to select a different interface.

Claim 28 (Original): An image forming apparatus comprising

a first display device

a second display device

means for providing a standard user interface to the first display device, the standard user interface including an option for the user to select an advanced interface

means for providing an operation guidance interface to the second display device

means for providing the advanced interface to the first display device and the second display device if a user selects the option for the advanced interface.

Claim 29 (Original): The image forming apparatus of claim 28, wherein the advanced interface includes an option for the user to select a custom interface and the standard interface lacks an option for the user to select a custom interface.

Claim 30 (Original): The image forming apparatus of claim 29 further comprising means for providing the custom interface to the first display device and the second display device if the user selects the option for the custom interface.

**REMARKS**

Claims 1-8 and 10-30 are pending. Claim 9 has been cancelled. Claim 11 has been amended to correct its dependency.

For the record: Before the application was filed and before the inventor signed the declaration, the undersigned was instructed to delete claim 9. Through an oversight, claim 9 remained when the application was filed. Shortly thereafter, the undersigned was reminded to cancel claim 9. A preliminary amendment was prepared one week after the application was filed, but filing of the preliminary amendment was deferred until the application number was known. This preliminary amendment belatedly addresses the oversight.
